



Port Credit BIA Scavenger Hunt

Official Rules and Regulations

The **Port Credit BIA Scavenger Hunt** (the “Event”) is organized and administered by the **Port Credit Business Improvement Area (Port Credit BIA)**.

By participating in the Port Credit BIA Scavenger Hunt, participants agree to comply with the following rules and regulations.

1. Eligibility

- The scavenger hunt is open to residents and visitors unless otherwise stated by the Port Credit BIA.
 - Participants under the age of **18 must have permission from a parent or legal guardian** or be accompanied by an adult.
 - Employees, board members, and individuals directly involved in organizing the event may not be eligible to win prizes unless otherwise specified.

2. Event Dates

- The **Port Credit BIA Scavenger Hunt runs from March 14, 2026 to March 21, 2026**.
 - All completed entry forms must be submitted by the end of the scavenger hunt period to be eligible.

3. Registration and Entry Forms

- Participants must complete and submit an **official Port Credit BIA Scavenger Hunt entry form**.
 - **Each entry form must be fully completed** to be eligible.
 - Incomplete, illegible, or late submissions may be disqualified at the discretion of the organizer.
 - Participants may submit multiple entries by visiting participating locations; however, **only one entry per person per location is permitted**.
 - **The more valid entries submitted, the greater the participant’s chances of winning.**

4. Team Participation

- Participants may participate individually or as part of a team.
 - Teams must follow the same rules as individual participants and must submit one completed entry form per entry.

5. Event Area

- The scavenger hunt takes place within the **designated Port Credit BIA area**.
 - Participants must not enter private property, restricted areas, or any location that may pose safety risks.
 - All participants must respect local businesses, residents, and public spaces.

6. Safety Requirements

Participants must:

- Follow all **local laws and traffic regulations**.
- Avoid unsafe or reckless behavior.
- Respect instructions given by Port Credit BIA staff, volunteers, and participating businesses.

The Port Credit BIA reserves the right to remove any participant acting in an unsafe or disruptive manner.

7. Respectful Conduct

Participants must:

- Respect participating businesses and their staff.
- Not damage, move, or remove property.
- Conduct themselves in a respectful and sportsmanlike manner throughout the event.

Failure to do so may result in disqualification.

8. Completion of Challenges

- Participants must complete the scavenger hunt tasks according to the instructions provided.
 - All answers must be recorded on the official entry form.
 - Any attempt to cheat, falsify answers, or interfere with other participants may result in disqualification.

9. Prize

- Eligible participants will be entered for a **chance to win a Family Gift Basket**.
 - The prize basket will contain **items and gift cards from participating Port Credit local businesses**.
 - The prize has **no cash value and cannot be exchanged for cash**.

10. Winner Selection

- One winner will be **randomly selected** from all eligible completed entries received during the event period.
 - The selected participant must correctly answer a **skill-testing question** in order to claim the prize, as required under Canadian contest regulations.

11. Photography & Media

By participating in the event, participants consent to the use of photographs or video taken during the scavenger hunt for promotional purposes by the **Port Credit BIA**, unless otherwise requested.

12. Liability

Participants acknowledge that they participate **at their own risk**.

The **Port Credit BIA, its staff, volunteers, partners, and participating businesses** are not responsible for any injury, loss, or damage that may occur during participation in the scavenger hunt.

13. Event Changes

The **Port Credit BIA** reserves the right to modify, postpone, or cancel the event due to weather, safety concerns, or unforeseen circumstances.

14. Acceptance of Rules

Participation in the **Port Credit BIA Scavenger Hunt** constitutes full acceptance of these official rules and regulations.
