All applications must be submitted no later than April 8th, 2022 and must include:

- 1. Payment for your requested stall
- 2. Payment for your City of Mississauga Mobile Vendor Permit (\$140)
 - a. Exemptions for this permit include:
 - i. Farmers with Ontario grown product who are selling their own harvest or homegrown product
 - ii. Vendors selling goods that are manufactured/produced in Ontario who are selling in the municipality where they live
- 3. Certificate of Insurance (see details below)

Applications are subject to approval and must be accompanied by full payment for your stall and mobile vendor permit. If your application is denied, we will return your cheque promptly with a full explanation. Additional vendor requirements must be met prior to the start of the market. All vendors must meet the criteria outlined by the organizer and vendor spots will be assigned on a first come first serve basis.

Additional Vendor Requirements:

- **1. Certificate of Insurance**: All vendors must provide Certificate of Insurance with a minimum of 2-million-dollar liability naming the City of Mississauga and Port Credit BIA as additional insured.
- 2. **Covid-19 Safety:** All vendors must adhere to the Port Credit Farmers Market Covid-19 Safety Plan (if applicable) as well as the Region of Peel Public Health Guidelines.
- 3. **Hours of Operation:** *Market hours are 8:00 am- 2:00 pm.* All vendors will adhere to the market hours of operation and will be operational every Saturday for the full duration of the market. If a vendor is absent 3 times, the vendor will be asked to leave and a refund will not be issued.
- 4. **Set-up & Equipment:** All vendors must supply their own equipment including weights for tents. Vendors are responsible for their own set-up and breakdown and must adhere to the set-up and breakdown times provided by the Port Credit BIA. Please note that weights for each tent leg are required or you will not be allowed to set up.
- 5. **Cancellations**: Must be submitted in writing **3 weeks** prior to opening. An administration fee of \$150 will be deducted from the total. If you cancel during Market season no refund will be issued.
